# ***Fare Thee Well* Partial Refund Program FAQ**

Please read instructions carefully.

## **1. Who is eligible to receive a partial refund?**

If you received tickets for one or more of the Soldier Field “Fare Thee Well” shows through GDTS TOO mail order and were charged more than the price of such tickets on the seating chart made available at the time your order was mailed, then you are eligible to receive a partial refund.

## **2. How much money will I receive?**

The amount of your partial refund will be equal to the difference between the face value of the GDTS TOO mail order ticket(s) you received and the price of such tickets on the seating chart made available at the time the order for your tickets was mailed to GDTS TOO.

## **3. How do I obtain my partial refund?**

To obtain your partial refund, you will need to mail a completed Claim Form, together with your original commemorative ticket(s) and a self-addressed, stamped envelope, to the following address:

Your envelope must be postmarked by no later than July 20, 2015.

## **4. What do I need to send?**

In order to claim your refund, you must send in a completed and signed Claim Form, your original commemorative ticket(s) to “Fare Thee Well,” and a self-addressed, stamped envelope. Make sure your SASE has sufficient postage for us to return your tickets to you, together with your partial refund.

## **5. Why do I need to send my tickets in to get a refund?**

In order to confirm eligibility and ensure that partial refunds are issued to the individuals who actually used the tickets, original commemorative tickets must be included with the claim form.

## **6. Do I have to have been the original GDTS TOO mail order purchaser to get a refund?**

You do not have to have been the original GDTS TOO mail order purchaser to claim a partial refund, but if you were not the original purchaser, you need to provide the name and email address of the original purchaser.

**7. Will I get my tickets back?**

As long as you include sufficient postage, we will send your original commemorative tickets back to you, together with your refund. We cannot be held responsible for items lost in the mail, however.

**8. In what form will I receive the refund?**

Your partial refund will be in the form of a check.

**9. Can I file more than one refund claim?**

You may file a claim for as many tickets as you purchased, up to four (4) tickets per show, which is the maximum number of tickets any single purchaser was permitted to order through GDTS TOO.

**10. When is the deadline to file a refund claim?**

Claims for partial refunds must be postmarked by Monday, July 20, 2015.

**11. How long until I receive my refund?**

Please allow 4-6 weeks for processing of partial refund claims.
